





The Directors have pleasure in presenting the 44<sup>th</sup> Annual Report of the Company, together with the financial statements, for the year ended 31<sup>st</sup> March, 2023.

### **1. Financial Performance**

### **2. Performance and State of Company's Affairs**

The Company has achieved total revenue of Rs. 6,46,80,792 as compared to Rs. 1,01,22,084 in the corresponding previous year. EBIDTA for the year was Rs. 1,01,12,679 as compared to Rs. 81,45,139 for the previous year. Profit after Tax (PAT) stood at Rs. 26,64,305 as against Rs. 16,05,996 in the previous year.

### **3. Reserve and Surplus**

Net surplus in the statement of Profit & loss for the financial year 2022-23 is carried to the Retained earnings.

### **4. Dividend**

The Board of Directors has not proposed any dividend for the Financial Year ended 31<sup>st</sup> March, 2023.

### **5. Deposits**

Your Company has not accepted any deposits covered within the meaning of Section 73 of the Companies Act, 2013 and the Companies (Acceptance of Deposits) Rules, 2014.

### **6. Change in the name of the Company**

During the year under review, the shareholders of the Company in their Extra Ordinary General Meeting held on 11<sup>th</sup> November, 2022, accorded their approval to change the name of the company from 'KLJ Plastics Limited' to 'Adilakshmi Enterprises Limited'. Consequent to the shareholders approval and Company's application for name change, the Registrar of Companies, Hyderabad, issued a fresh certificate of incorporation, confirming change in the name of the Company, effective from 27<sup>th</sup> December, 2022.

The Company also applied for 'In-principle approval' of Calcutta Stock Exchange Limited (hereinafter 'CSE') for change of the name of the Company as stipulated under Regulation 45 of SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015. The CSE vide its letter dated 3<sup>rd</sup> November, 2022, provided the said In-principle approval. Further, an application for 'Final approval' was also submitted to CSE for change in the name of the company and the CSE granted its Final approval vide its letter dated 13<sup>th</sup> February, 2023.

### **7. Directors and Key Managerial Personnel**

Smt. Kalpana Seth (DIN: 06949098), Director of the Company retires at the ensuing Annual General Meeting and being eligible seeks re-appointment. The Nomination and Remuneration Committee and the Board of Directors recommend her re-appointment. A brief resume of Smt. Kalpana Seth proposed to be re-appointed, as stipulated under SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015 and the Secretarial Standards on General Meetings (SS-2) issued by the Institute of Company Secretaries of India, is provided in notes to the notice forming part of the Annual Report.

Further, during the year under review, Ms. Divya Bajaj was appointed as Company Secretary of the Company, effective from 27<sup>th</sup> December, 2022 and Ms. Chhavi Sharma, Company Secretary has resigned from the Company with effect from 26<sup>th</sup> December, 2022.

#### **8. Declaration from Independent Directors**

The Company has received declarations from all the Independent directors of the Company confirming that they meet the criteria of Independence as prescribed under sub-section (6) of Section 149 of the Companies Act, 2013 and under Regulation 16 (1)(b) of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 as amended. The declarations received from all the Independent directors were taken on record by the Board of Directors.

In the opinion of the Board, all the Independent Directors possess the integrity, expertise and experience including the proficiency required to be Independent Directors of the Company, fulfill the conditions of independence as specified in the Act and the Listing Regulations and are independent of the management and have also complied with the Code for Independent Directors as prescribed in Schedule IV of the Companies Act, 2013.

#### **9. Change in Nature of business**

The Company was engaged in the business of manufacturing of woven sacks, HDPE and PP bags. The Company was in lockout from 2<sup>nd</sup> May, 1997 to 15<sup>th</sup> October, 2002 and subsequently, the Company closed its operations with effect from 25<sup>th</sup> April, 2004 due to labour unrest. Further, the Company has altered its main object to undertake trading business activities related to chemical and petrochemicals products, derivatives and solvents of petrochemicals and other tradeable commodities which shall be more advantageous to the growth of the Company. Accordingly, the Company has altered its main object clause of Memorandum of Association by adding a new-clause no. 3, which has been approved by the shareholders in their Annual General Meeting by way of a special resolution dated 29<sup>th</sup> September, 2022, which was confirmed by Registrar of Companies, Hyderabad vide their certificate dated 9<sup>th</sup> November, 2022. The newly added sub-clause no. 3 is reproduced herein below:

*“To carry on the business as importers, exporters, processors, buyers, sellers, suppliers, stockiest, agents, merchants, distributors, wholesalers and marketers of Chemical and Petrochemical products, compounds, polymers, base oil, organic and inorganic chemical products, derivatives and solvents of petrochemicals and all kind of chemical products and other tradeable commodities”.*

#### **10. Statutory Auditors and Auditor's Report**

Pursuant to the provisions of Section 139 of the Act read with Companies (Audit and Auditors) Rules, 2014 as amended from time to time M/s Laxminiwas & Co., Chartered Accountants (Firm Registration No. 011168S), were appointed as Statutory Auditors of the Company for a period of 5 years from the conclusion of 43<sup>rd</sup> Annual General Meeting of the Company till the conclusion of the 48<sup>th</sup> Annual General Meeting to be held in the year 2027, to carry out the statutory audit for financial year 2022-23 to 2026-27, at a remuneration as mutually decided between the Statutory Auditors and the Company.

The Auditor's Report for the financial year 2022-23, is qualified wherein the statutory auditors have stated that value of building in the Balance sheet includes Rs. 19,04,551 as value of Guest House that is not in the possession of company.

*The Board of Directors states that the ownership of the building and sale transaction is challenged in the Civil Court at Hyderabad to declare the transaction null and void.*

#### **11. Secretarial Audit and Secretarial Audit Report**

M/s. Deepti Chawla & Associates, Company Secretaries (ICSI COP No. 8759), New Delhi, a firm of Company Secretaries in Practice have conducted Secretarial Audit of the Company for the financial year 2022-23. The Secretarial Audit Report for the financial year ended 31<sup>st</sup> March, 2023 is annexed herewith as 'Annexure -A' to this Report.

The Secretarial Auditor has given following observation(s) in her report dated 31<sup>st</sup> August, 2023:

- (i) the Company has not provided remote e-voting facility to the shareholders as per the applicable provisions of the Companies Act, 2013. The Board of Directors states that the Company will take suitable steps to comply with the same.
- (ii) the shareholding of promoter(s) and promoters group is not in dematerialised form as required under regulation 31(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The Board of Directors states that the Company is taking suitable steps, post Tripartite Agreement with CDSL and NSDL to dematerialise the shares of the promoters.

(iii) the Company is not complying with the applicable provisions of SEBI (Prohibition of Insider Trading) Regulations 2015. The Board states that the equity shares of the Company are listed on Calcutta Stock Exchange Limited and the shares of the Company are not traded, for past many years.

**12. Conservation of Energy, Technology Absorption, Foreign Exchange Earnings and Outgo**

In the opinion of the Board, the particulars in respect of conservation of energy and technology absorption, as required under Section 134(3) (m) of the Companies Act, 2013 read with the Companies (Accounts) Rule, 2014 have not been provided as the energy consumption by the Company was minimal and the Company was not required to absorb any new technology as there were no operations in the company during financial year 2022-23.

The Company has neither earned any foreign exchange nor has any foreign exchange outgo during the year.

**13. Number of Meetings of the Board and Board Committees**

9 (Nine) meetings of the Board were held during the financial year 2022-23. For details of the meetings of the Board, please refer to the Corporate Governance Report, which forms part of the Annual Report. The Company has the following Board Committees:





### **B. Definitions**

**Directors:** Directors other than Whole-time Director(s) and/or Managing Director(s) appointed under the provisions of the Companies Act, 2013 and rules made there under.

**Key Managerial Personnel:** Whole Time Director, Chief Financial Officer and Company Secretary.

**Senior Management Personnel:** Members of the Corporate Leadership Team of the Company and Key Managerial Personnel.

### **C. Terms of Reference**

The Board of Directors of the Company has constituted a Nomination and Remuneration Committee. Its terms of reference are as follows:

- Formulation of the criteria for determining qualifications, positive attributes and independence of a director.
- Formulation of criteria for evaluation of Independent Directors and the Board.
- Formulation of policies for remuneration to Directors, Key Managerial Personnel and Senior Management Personnel.
- to determine or recommend the appointments of Executive, Non-Executive Directors to the Board.
- identify the candidates who have qualified to become directors and to recommend all elements of remuneration packages of Executive and Non-executive directors.

### **D. Criteria for recommending a person to become a Director**

The Committee shall take into consideration the following criteria of qualification, positive attributes and independence for recommending to the Board, the appointment of Director(s).

#### **1. Qualifications & Experience**

The incumbent should have appropriate skills, experience and knowledge in one or more fields of finance, law, management, sales & marketing, operations, research, corporate governance, education, community service or other disciplines.

#### **2. Attributes/Qualities**

The incumbent Director should have one or more of the following attributes:

- Respect for and strong willingness to imbibe the Company's Core Values.
- Honesty and Professional integrity.
- Strategic capability with business vision.
- Entrepreneurial spirit and track record of achievements.
- Ability to be independent.
- Reasonable financial expertise.
- Association in the fields of Business/Corporate world/Finance/Education/Community Service.

### **E. Eligibility Criteria & Remuneration of Key Managerial Personnel & Senior Management Personnel**

The eligibility criteria for appointment of key managerial personnel and senior management personnel shall be in accordance with the job description of the relevant position. In particular, the position of Key Managerial Personnel should be filled by senior personnel having relevant qualifications and experience.

The remuneration structure for Key Managerial Personnel and Senior Management Personnel shall be as per the Company's remuneration structure taking into account factors such as level of experience, qualification, performance and suitability which shall be reasonable and sufficient to attract, retain and motivate them.


The remuneration may consist of fixed and incentive pay/retention bonus reflecting short and long-term performance objectives appropriate to the working of the Company and its goals.

**Qualified Opinion**

We have audited the accompanying financial statements of **Adilakshmi Enterprises Limited (Formerly known as KLJ Plastics Limited)** ("the Company") which comprise the Balance Sheet as at 31<sup>st</sup> March, 2023, the Statement of Profit and Loss (including Other Comprehensive Income), the Cash Flow Statement and the Statement of Changes in Equity for the year then ended and notes to the financial Statements, including a summary of the significant accounting policies and other explanatory information (hereinafter referred to as "the financial statements").

In our opinion and to the best of our information and according to the explanations given to us, except for the possible effect of the matters described in the basis of Qualified opinion paragraph, the aforesaid financial statements give the information required by the Companies Act, 2013, as amended ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India specified under Section 133 of the Act, of the state of affairs (financial position) of the Company as at 31<sup>st</sup> March 2023, its profit (financial performance including other comprehensive income), its cash flows and the changes in equity for the year ended on that date.

**Basis for Qualified Opinion**

The company's Balance sheet includes property plant & equipment containing a guest house building carried at Rs. 6,36,159 as at 31st March 2023 (Rs. 7,22,699 as at 31st March 2022) with gross value at Rs. 19,04,551. The said guest house is not in the possession of the company. The ownership of the building and sale transaction is challenged in the Civil Court at Hyderabad to declare the transaction null and void refer note no. 24 of the financial statements for further details.

We conducted our audit of the financial statements in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion on the financial statements.



### Emphasis of Matter

We draw attention to Note 22 of the financial statements which states that the company has allotted redeemable Non-convertible preference share which are due for redemption in the year 2023-24 wherein preference shareholders have requested to company's Board of Directors to extend the due date for redemption of preference shares by another 5 years. The same is proposed for approval by board during the financial year 2023-24 and appropriate impact as per Ind AS will be provided in the books of accounts post such approval. Accordingly, the company continues to present such outstanding preference shares under Non-current liabilities.

Our opinion is not modified in respect of this matter.

### Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period.

Based on our audit and professional judgment, we have determined that there are no key audit matters.

### Other Information

The Company's Board of Directors is responsible for the other information. The other information comprises the information included in the Annual Report but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we will not express any form of assurance conclusion thereon.

	Adilakshmi Enterprises Limited (Formerly known as KLJ Plastics Limited) (the Company) was incorporated on 09th August, 1978.
<b>2.0</b>	<b>Significant accounting policies</b>
<b>2.1</b>	<b>Statement of Compliance</b>
	The financial statements of the Company have been prepared in accordance with Indian Accounting standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 and Companies Accounting Standard (Amendment Rules 2016).

### 2.6 Revenue recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured, regardless of when the payment is being made. Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duties collected on behalf of the government.

#### Sale of goods

Revenue from the sale of goods is recognised when the significant risks and rewards of ownership of the goods have passed to the buyer, usually on delivery of the goods. Revenue from the sale of goods is measured at the fair value of the consideration received or receivable, net of returns and allowances, trade discounts and volume rebates.

#### Interest income

Interest Income from financial asset is recognised when it is probable that the economic benefits flow to the company and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the asset's net carrying amount on initial recognition.

### 2.7 Taxes

#### Deferred tax

Deferred tax is provided using the liability method on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- (i) When the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss
- (ii) In respect of taxable temporary differences associated with investments in subsidiaries, associates and interests in joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future

Deferred tax assets are recognised for all deductible temporary differences, the carry forward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carry forward of unused tax credits and unused tax losses can be utilised, except:

- (i) When the deferred tax asset relating to the deductible temporary difference arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss
- (ii) In respect of deductible temporary differences associated with investments in subsidiaries, associates and interests in joint ventures, deferred tax assets are recognised only to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised

The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at each reporting date and are recognised to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.

Deferred tax relating to items recognised outside profit or loss is recognised outside profit or loss (either in other comprehensive income or in equity). Deferred tax items are recognised in correlation to the underlying transaction either in OCI or directly in equity.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority.

### 2.8 Property, plant and equipment

Fixed assets are stated at cost, net of accumulated depreciation and accumulated impairment losses, if any. The cost comprises purchase price, non refundable taxes and directly attributable cost of bringing the asset to its present location and condition for the intended use. Any trade discounts and rebates are deducted in arriving at the purchase price.

The Company has elected to regard the carrying values of Freehold land and buildings as deemed cost since they were broadly comparable to fair value. Accordingly, the company has not opted for Fair Valuation of noncurrent assets at 1 April 2016. Depreciation on tangible fixed assets has been provided on the straight-line method as per the useful life prescribed in Schedule II to the Companies Act, 2013.

**Note****De-recognition and subsequent cost**

Subsequent costs incurred for replacement of a major component of an asset should be included in the asset's carrying cost or recognised as a separate asset, as appropriate. The carrying value of the replaced component should be charged to Profit and Loss account when replaced.

**De-recognition**

An item of property, plant and equipment and any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the income statement when the asset is derecognised.

**2.9 Inventories**

Inventories are valued at the lower of cost and net realisable value.

Costs incurred in bringing each product to its present location and condition are accounted for as follows:

- (i) Raw materials: cost includes cost of purchase and other costs incurred in bringing the inventories to their present location and condition. Cost is determined on weighted average basis..
- (ii) Finished goods and work in progress: cost includes cost of direct materials and labour. Cost is determined on weighted average basis.
- (iii) Traded goods: cost includes cost of purchase and other costs incurred in bringing the inventories to their present location and condition. Cost is determined on weighted average basis.

Net realisable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and the estimated costs necessary to make the sale.

**2.10 Provisions****General**

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

**2.11 Retirement and other employee benefits**

Employee benefits include provident fund, employee state insurance scheme, gratuity fund and compensated absences.

**Defined contribution plans**

Retirement benefit in the form of provident fund is a defined contribution scheme. The contributions to the provident fund are charged to the statement of profit and loss for the year when the contributions are due.

**2.12 Financial instruments**

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

**Financial assets****Initial recognition and measurement**

All financial assets are recognised initially at fair value plus, in the case of financial assets not recorded at fair value through profit or loss, transaction costs that are attributable to the acquisition of the financial asset. Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognised on the trade date, i.e., the date that the company commits to purchase or sell the asset.

**Subsequent measurement**

For purposes of subsequent measurement, financial assets are classified in four categories:

- (i) Debt instruments at amortised cost
- (ii) Debt instruments at fair value through other comprehensive income (FVTOCI)
- (iii) Debt instruments, derivatives and equity instruments at fair value through profit or loss (FVTPL)
- (iv) Equity instruments measured at fair value through other comprehensive income (FVTOCI)

## Note

### Debt instruments at amortised cost

A 'debt instrument' is measured at the amortised cost if both the following conditions are met:

- The asset is held within a business model whose objective is to hold assets for collecting contractual cash flows, and
- Contractual terms of the asset give rise on specified dates to cash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding.

This category is the most relevant to the company. After initial measurement, such financial assets are subsequently measured at amortised cost using the effective interest rate (EIR) method.

### Equity investments

All equity investments in scope of Ind AS 109 are measured at fair value. Equity instruments which are held for trading and contingent consideration recognised by an acquirer in a business combination to which Ind AS103 applies are classified as at FVTPL. For all other equity instruments, the company may make an irrevocable election to present in other comprehensive income subsequent changes in the fair value. The company makes such election on an instrument by- instrument basis. The classification is made on initial recognition and is irrevocable.

If the company decides to classify an equity instrument as at FVTOCI, then all fair value changes on the instrument, excluding dividends, are recognized in the OCI. There is no recycling of the amounts from OCI to P&L, even on sale of investment. However, the company may transfer the cumulative gain or loss within equity.

### Derecognition

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e. removed from the Group's consolidated balance sheet) when:

- The rights to receive cash flows from the asset have expired, or
- The company has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass-through' arrangement; and either
  - the company has transferred substantially all the risks and rewards of the asset, or
  - the company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

## Financial liabilities

### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The company's financial liabilities include trade and other payables, loans and borrowings including bank overdrafts, financial guarantee contracts and derivative financial instruments.

### Subsequent measurement

The measurement of financial liabilities depends on their classification, as described below:

### Loans and borrowings

This is the category most relevant to the company. After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the EIR method. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the EIR amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included as finance costs in the statement of profit and loss.

### Derecognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of profit or loss.

## 2.13 Cash and cash equivalents

Cash and cash equivalent in the balance sheet comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value.

For the purpose of the statement of cash flows, cash and cash equivalents consist of cash and short-term deposits, as defined above, net of outstanding bank overdrafts as they are considered an integral part of the Company's cash management.

**Note****2.14 Earnings per share**

Basic earnings per share is computed by dividing the profit / (loss) after tax (including the post tax effect of extraordinary items, if any) by the weighted average number of equity shares outstanding during the year.

Diluted earnings per share is computed by dividing the profit / (loss) after tax (including the post tax effect of extraordinary items, if any) as adjusted for dividend, interest and other charges to expense or income (net of any attributable taxes) relating to the dilutive potential equity shares, by the weighted average number of equity shares considered for deriving basic earnings per share and the weighted average number of equity shares which could have been issued on the conversion of all dilutive potential equity shares.

Potential equity shares are deemed to be dilutive only if their conversion to equity shares would decrease the net profit per share from continuing ordinary operations. Potential dilutive equity shares are deemed to be converted as at the beginning of the period, unless they have been issued at a later date. The dilutive potential equity shares are adjusted for the proceeds receivable had the shares been actually issued at fair value (i.e. average market value of the outstanding shares). Dilutive potential equity shares are determined independently for

**2.15 Impairment of assets**

The carrying values of assets / cash generating units at each balance sheet date are reviewed for impairment. If any indication of impairment exists, the recoverable amount of such assets is estimated and impairment is recognised, if the carrying amount of these assets exceeds their recoverable amount. The recoverable amount is the greater of the net selling price and their value in use. Value in use is arrived at by discounting the future cash flows to their present value based on an appropriate discount factor. When there is indication that an impairment loss recognised for an asset in earlier accounting periods no longer exists or may have decreased, such reversal of impairment loss is recognised in the Statement of Profit and Loss, except in case of revalued assets.

**2.16 Provisions and contingencies**

A provision is recognised when the Company has a present obligation as a result of past events and it is probable that an outflow of resources will be required to settle the obligation in respect of which a reliable estimate can be made. Provisions (excluding retirement benefits) are not discounted to their present value and are determined based on the best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date and adjusted to reflect the current best estimates. Contingent liabilities are disclosed in the Notes. Contingent assets are not recognised in the financial statements.

Contingent Assets are neither recognised nor disclosed in the financial statements.

Contingent liability is disclosed for:

- Possible obligations which will be confirmed only by future events not wholly within the control of the Company or
- Present obligations arising from past events where it is not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount of the obligation cannot be made.

**2.17 Operating Cycle**

Based on the nature of products / activities of the Company and the normal time between acquisition of assets and their realisation in cash or cash equivalents, the Company has determined its operating cycle as 12 months for the purpose of classification of its assets and liabilities as current and non-current.

### Financial risk management

The Company's financial risk management is an integral part of how to plan and execute its business strategies. The Company's activities expose it to a variety of financial risks: credit risk, liquidity risk and market risk. The Company's primary focus is to foresee the unpredictability of financial markets and seek to minimise potential adverse effects on its financial performance.

#### Credit risk

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations and arises principally from the Company's receivables from customers and loans given. Credit risk arises from cash held with banks and financial institutions, as well as credit exposure to clients, including outstanding accounts receivables. The maximum exposure to credit risk is equal to the carrying value of the financial assets. The objective of managing counterparty credit risk is to prevent losses in financial assets. The Company assesses the credit quality of the counterparties, taking into account their financial position, past experience and other factors.

#### Liquidity risk

Liquidity risk is the risk that the Company will encounter difficulty in meeting the obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Company's approach to managing liquidity is to ensure, as far as possible, that it will have sufficient liquidity to meet its liabilities when they are due, under both normal and stressed conditions, without incurring unacceptable losses or risking damage to the Company's reputation.

#### Market risk

Market risk is the risk that changes in market prices - such as foreign exchange rates and interest rates - will affect the Company's income or the value of its holdings of financial instruments. The objective of market risk management is to manage and control market risk exposures within acceptable parameters, while optimising the return.

## 22 Preference Share

The company has allotted 9,54,446 redeemable Non convertible preference share of Rs. 100/- each at par by conversion of Secured Loans/Unsecured / Other outstanding Dues/liabilities. In the FY 2020-21, 1,65,706 preference share are redeemed at par @ Rs.100 and remaining preference share are due for redemption in the year 2023-24. The remaining preference shareholders have requested to company's Board of Directors to extend the due date for redemption of balance preference shares by another 5 years i.e. the preference share will be redeemed during the financial year 2028-29 at par @ Rs.100/ per share. The same will be proposed for approval by board during the financial year 2023-24 and appropriate impact as per Ind AS will be provided in the books of accounts post such approval. Accordingly, the company continues to present such outstanding preference shares under Non-current liabilities.

## 23 Share capital

Share Capital of the company was reduced in earlier years from 3,00,00,000 (Divided into 30,00,000 equity share of Rs.10 /- each to Rs.30,00,000 (Divided into 30,00,000 equity share of Rs.1/- each) and said 30,00,000 equity shares of Rs. 1/- (Rupee one only) be consolidated and divided into 300000 equity share of Rs. 10/- (Rupee Ten only) each. Reduction having been confirmed by an order of Hon'ble High Court, Andhra Pradesh.

The Building Includes Rs. 19,04,551/- Value of Guest house that is not in the possession of the company. The ownership of the building and sale transaction is challenged in the Civil Court at Hyderabad to declare the transaction null and void.
